Over the last two terms, school council have been working with Global Action to think about ways to reduce air pollution around our school environment. The school was given a grant of £3,000 to spend on a green screen (plant wall) in the Early Years playground facing outwards towards Tower Bridge Road to reduce some of the polluted air that our youngest children breathe in. We will also be investing in some more scooter and bike racks to promote walking to school as opposed to using other modes of transport like buses or cars which will support our anti-idling drive.
